

Application form: Islington Self-build and Custom Housebuilding register

Islington's Self-build and custom housebuilding register is divided into two parts:

- Part 1 keeps track of local demand for self-build and custom housebuilding which must be met via the grant of sufficient development permissions for serviced plots of land.
- Part 2 keeps track of general demand for self-build and custom build, with no requirement togrant sufficient development permissions for serviced plots of land to meet this demand.

Eligibility for Part 1 or Part 2 of the register is dependent on submission of appropriate information required by regulations and to address local eligibility conditions. Local eligibility conditions include:

- a requirement to demonstrate a 'local connection', which applies to all applications for Part 1 of the register (an exception applies to persons in the service, or who have been in recent service of, the regular armed forces of the Crown); and
- a requirement to demonstrate sufficient financial resources to purchase land, which applies to Parts 1 and 2 of the register.

Further detail about the different parts to the register and local eligibility conditions can be found in the accompanying guidance notes available on the council's <u>website</u>.

You should provide all the necessary information with the completed application form to allow for applications to be assessed. Following receipt of your application we will assess the information you have provided and confirm in writing if you are, or are not, eligible for entry in Part 1 or Part 2 of the register as appropriate. If an application is incomplete or there is insufficient information for it to be assessed, this may result in applications being refused.

If you are accepted on to the register this will be conditional on the receipt of the required fee and you may be removed from the register if this fee is not paid. Further information about fees and how to pay can be found in the fees guidance note available on the council's website.
